Please ensure that the emergency contact information is filled out on the "Childcare Application Form," and respond promptly if contacted.</li> <li>Childcare staff cannot administer any medications.</li> <li>Please be punctual for both drop-off and pick-up times.</li> <li>If the person picking up your child is different from the person who dropped them off, please inform the staff at the time of drop-off.</li> <li>Please label all of your child's belongings.
